Order:

In the Government Order first read above orders were issued prescribing certain guidelines for the "Moovalur Ramamirtham Ammaiyar Marriage Assistance Scheme".

2) In the Election Manifesto, 2011 among other things, the Hon'ble Chief Minister has announced the following:-

Due to huge increase in price of Gold, Four Grams Gold (1/2 Sovereign) may be given for making 'Thirumangalyam' in addition to the Marriage Assistance of Rs.25,000/- to each beneficiary.

3) In the letter third read above the Director of Social Welfare in her proposal has stated that in addition to the financial assistance of Rs.25,000/- per beneficiary under various Marriage Assistance Schemes 4 grams of 22 ct gold may be provided for making Thirumangalyam to all the beneficiaries under all the five existing marriage

assistance schemes, as announced by the Hon'ble Chief Minister in the Assembly Election Manifesto, 2011.

4) After careful examination of the proposal of the Director of Social Welfare, the Government accept the Financial Assistance of Rs.25,000/- per beneficiary along with 4 grams of 22 ct gold for making Thirumangalyam to all the beneficiaries under the marriage scheme and sanction is accorded for Rs.118.18 crores (Rupees One hundred and eighteen crores and eighteen lakhs only) towards purchase of four grams Gold (1/2 sovereign) 22 ct at free of cost per beneficiary for making Thirumangalyam' in addition to the existing marriage assistance of Rs.25,000/- under the various Marriage Assistance Scheme.

5) The expenditure sanctioned in para 4 above shall be debited under the existing head of account, suitably as annexed to this order.

6) The expenditure sanctioned in para 4 above constitute an item of "New Instrument of Service" and the approval of the Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure will initially be met from the contingency fund, for which orders will be issued from Financial (BG.1) Department. The Director of Social Welfare is requested to send necessary proposals in the prescribed format to Finance (BG.1) Department for drawal of Contingency Fund advance with enclosing the copy of the same. The Director of Social Welfare is also requested to send explanatory notes to Financial (BG.1) Department for inclusion in the Supplementary Estimates 2011-2012, at the appropriate time.

7) This order issues with the concurrence of the Finance Department vide its U.O.No. 85/DS(B)/SW/2011, dated 17.05.2011 and ASL No. 49 (Forty Nine).
